36 single frames – 6 rounds of 6 single frames on 2 tables (Home and Away Format may be used)

**Please Note:** Depending on the amount of teams entered we may hold a Friday night session, starting at approximately 7.00pm (This would involve the Southern Teams)

Team Qualifications: Association may enter Teams based on the amount of registered players in that Association

Up to 99 Registered Players – 1 Team

100 + Registered Players – 2 Teams

The Team/s must be a side that plays together in a recognised roster that the Association runs. No combined teams or composites of teams are allowed to enter.

Player Qualifications: To qualify to represent a Member Association at Eightball Tasmania Teams Event, a player must have played in no less than 5 roster matches, in the recognised roster that the team is entered in the State Teams Event.

To play in Finals of State Teams Event a player must have played in 2/3 of scheduled matches and played 1 frame in each match played

Entry Fee for State Teams Event is \$50.00, payable by Friday 5<sup>th</sup> March 2010 - Payment to be received by due date for Team Entered and made payable to - Eightball Tasmania - PO Box 275, Prospect 7250
